## LCH SA: Treasury Reports Redesign Project, Timeline & Documentation Update

Dear LCH SA Members,

Following the latest communication from 25 October, we would like to update you on the Treasury Reports Redesign Project, release scope as well as timelines, in particular the extension of the parallel run period to provide your firm with more time and secure / smoothen your migration.

## Updated Release Scope & Timeline

The parallel run has been **extended until 25 February 2022** for both .txt and .xml reports\* since the last release completing the project will take place in January 2022.
